### WEBINAR: The Perfect and the Good: Engaging People around Harm Reduction and Non-Abstinence Based Goals

On June 20 at 11 a.m., the Mountain Plains Addiction **Technology Transfer Center** will host a webinar titled "The Perfect and the Good: Engaging People around Harm Reduction and Non-Abstinence Based Goals." This presentation will be presented by Scott Walters, Ph.D., who will review the current literature on harm reduction, discuss factors affecting strategy suitability and effectiveness, and demonstrate how to use motivational interviewing to engage and motivate clients in adopting strategies to minimize drug use risks. By actively involving individuals in harm reduction, providers can optimize benefits and support the well-being of people with Opioid Use Disorder (OUD).

## UTAH PROGRAM ANNOUNCEMENT: COMMUNITY BRIDGE PROGRAM



Utah's Community Bridge Program allows
Emergency Medical Services (EMS) in rural areas to
connect a person experiencing opioid poisoning
(after revival) to recovery resources. If the person
accepts, EMS administers the first dose of
buprenorphine to the patient. Following is a
"Program Sketch:"

- 911 call for opioid overdose; EMS responds.
- If the patient is identified as stable per EMS protocol, EMS notifies Utah Support Advocates for Recovery Awareness (USARA).
- USARA is dispatched to the scene to meet with EMS to invite patient to enroll into the Community Bridge Program.
- If patient is enrolled, the patient receives a first dose of buprenorphine by EMS, following EMS protocol.
- USARA provides a warm-handoff to the MOUD provider and Case Manager from the "Bridge Clinic" (Huntsman Mental Health Institute Addiction Recovery Clinic).
- The patient will receive a five-day prescription for buprenorphine until continuity can be provided by the Bridge Clinic.

### Human Services in Rural Contexts: Comprehensive Report and Accompanying Briefs Share Opportunities and Challenges

PACIFIC SOUTHWEST ROTA-R--This new report, accompanied by seven briefs, provides information on how human services operate in rural contexts. The report illustrates the remaining need for human services in rural communities and the unique challenges and opportunities that exist to address this remaining need. The first three briefs delve into more detail about specific topics relevant to human services programs in rural areas. The Broadband Access brief discusses how rural areas lack access to broadband internet and how this impacts rural communities. The Housing Supports brief describes the need for housing in rural communities and the existing supports which work to address this need.

# Heat Health Awareness: Why It's Important For Persons With SUD & Mental Health Conditions, Caregivers & Health Care Providers

SAMHSA--Last year, amidst one of the warmest global summers recorded, the Biden Administration launched Heat.gov as a "a one-stop hub on heat and health for the nation." The website provides information on at-risk groups, tools and resources, and ways to prepare for extreme heat. Heat.gov is overseen by the National Integrated Heat Health Information System (NIHHIS), an interagency collaboration that includes the National Oceanic and Atmospheric Administration, Centers for Disease Control and Prevention (CDC), Federal Emergency Management Agency, Administration for Strategic Preparedness and Response and the Substance Abuse and Mental Health Services Administration (SAMHSA).
